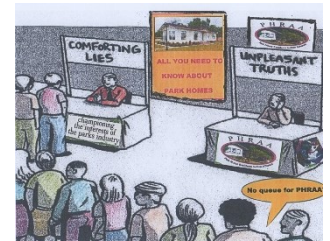

PHRAA BANNED BY FACEBOOK! IS THIS THE LATEST PARK HOME INDUSTRY'S ONGOING ATTEMPTS TO CRUSH THE VOICE OF SUFFERING PARK HOME RESIDENTS??

We must first offer our sincere apologies to all our fellow park homeowners, (including holiday caravan and lodge owners,) friends, supporters and readers of our regular, "TELLS IT AS IT IS" unique, online free to view and download magazine "PARK HOMES PHRAA NEWS" for the sudden disappearance of PHRAA information and other announcements usually published on the PHRAA Facebook page. From our investigations it would seem PHRAA has been banned by facebook. We can only assume that PHRAA's outspoken, but strictly truthful, facebook posts has upset the industry in some way.

As this ban commenced on about the 2nd December 2020 we can only assume that certain people complained to facebook regarding our posting of an article concerning the length of time park home residents currently have to wait for the Decision by the First Tier Tribunal System on all cases, especially, as in our own case, a serious and life changing verdict, which should it go against us, could have devastating results for myself and family by making us homeless!

The gist of our posting on the PHRAA facebook page and the Ron Joyce Timeline on the 2nd December 2020 is reproduced from memory below.....

"IS THIS A FORM OF PUNISHMENT INFLICTED ON ELDERLY AND VULNERABLE PARK HOMEOWNERS WHO STAND UP AGAINST RUTHLESS< BULLYING > ABUSIVE UNSCRUPULOUS PARK OWNERS?"(UPO's)

Most of our friends, fellow park homeowners, especially followers of the PHRAA websites, www.parkhomesphraanews.co.uk and www.thephraa.website, will be familiar with our ongoing battles with our own multiple park owner, Mr. C.S Nedic of Nedic Park Home Estates Ltd, Also trading as "Sovereign Parks" and "Cotswold Country Park" etc.

Following over twenty years of suffering abuse, harassment, intimidation, Mr. Nedic has now engaged the services of a well-known, very "clever" specialist solicitor, a Mr. John Clement, of IBB Law, (late of Turbervilles), who, no doubt, is well known to many of our fellow park homeowners, as he often works for such park owners.

To cut a long story short, Mr. Nedic and Clement, in order to apply never ending pressure on Ron Joyce Owner and occupier of 5, Silver Poplars Park since October 1987., to abandon his home to Nedic., have applied to the First Tier Tribunal for an order to compel Ron, and his family to have his home permanently moved to another pitch because they claim Ron's home is obstructing Nedic's redevelopment plans. ***(It should be pointed out to the reader and our fellow park homeowners nationally, that it is against the Mobile Homes Act 1983/2003 for the park owner to move a resident's park home to facilitate redevelopment of the park and should such an order be issued, it will have potentially disastrous results for all park home owners nationally).***

We strongly suspect that the main reason that facebook have allegedly banned the 2nd December article Ron posted on the PHRAA facebook page was that he highlighted the very real stress to the victim resident caused by the long delay that takes place between the date of the actual Tribunal Hearing to the date that the long suffering homeowner (Respondent) is notified of the Tribunal Decision. In Ron's case the main Hearing took place by video link on the 22nd October 2020. At the time of writing, it is now the 14th December 2020. Does this mean that Ron and his family have this uncertainty is going to hang over him until, or after, Christmas??.

No doubt Messes Nedic and Clement will be very happy at this extra pressure on the 81 year old disabled Ron and his family whose only crime is to stand up for his and his fellow park homeowners rights to a long overdue fair deal and legally easily enforceable rights

Whichever way this case against Ron goes, we at PHRAA still maintain that nearly two months further uncertainty, coming on top of over twenty years of endless illegal abuse and pressure from a ruthless park owner is totally unreasonable, especially when the victims are the elderly and vulnerable park homeowners.

The moral of this story is if you are a park homeowner and wish the general public to be made aware of the true state of the park Home Industry, where UPO's and their "clever" Solicitors are involved, be very careful about posting your experiences/ opinions on facebook. You may find you are banned for daring to speak out.
